## 'Love Bite' Recorded in Bone Shark Mating Behaviour

Scientists in Australia have witnessed whale shark mating behaviour at Ningaloo Reef, in what is believed to be the first documented recording of 'pre-copulatory' biting.

In a recent video post on YouTube by the Centre for Sustainable Aquatic Ecosystems in Western Australia a mature male whale shark is seen following a smaller female before lunging forward and biting her tail fin. The female shark, seemingly uninterested in his advances, pivots around the male before swimming into the depths. The male is seen following her before the researchers lose sight of the two sharks.





Ningaloo Reef, on the north-western tip of Australia, is as famous as St Helena for bone shark sightings and occasional glimpses of mating behaviour. Dive magazine reported this week, 'Very little is known about the mating behaviour of whale sharks (Rhincodon typus) which has, to date, only been observed in the wild in two places in the world – at Ningaloo Reef and the South Atlantic Island of St Helena, where adult male and female whale sharks gather in almost equal numbers between December and March each year.'

Dive added in their report, 'In 2005 and 2007 fishermen from St Helena reported incidents in which whale sharks 'came belly to belly' near the water's surface – presumably in the act of mating. Although there is no photographic record of the two encounters, in 2019 a male whale shark was photographed behaving similarly to the new Ningaloo video, following the female and positioning his snout against her tail fin in what is thought to be 'pre-copulatory' behaviour.

# Two Acting Attorney Generals and Three Appointments Since David Ballantyne's Resignation

Former Attorney General, David Ballantyne, announced his resignation at Legislative Council on 6th December. This came as an obvious surprise to many. However, arrangements were made to replace him. In the most recent issue of the St Helena Government Gazette, it is announced Matthew James, the crown counsel on Ascension, took over in an acting capacity the following day – 7th December.

David Ballantyne promptly departed on a flight the following week, probably never to be seen again. Matthew James also left the post of acting attorney general just 13 days after being appointed 'with effect from 7 December 2024 and until further notice', as announced in the Gazette. As this tale tells you, we do see him again.


Mr James was replaced by Sara McIlroy (a crown counsel for St Helena) on 20th December at

8:30am precisely. The Government Gazette announced Ms McIlroy will act as Acting Attorney General until 4pm (precisely) on 6th January.

Sara McIlroy was in office for 17 days while most of the rest of the government offices were firmly closed for the Christmas/New Year holiday. A big hand here for the rubbish collectors, police, doctors, nurses and emergency responders of all kinds who worked during the break.

At 4pm on 6th January, up stepped Matthew James once more to take up the reins of the Attorney General's Chambers. Mr James will be in place until 7th February (actual time of departure not specified) after which, who knows what will happen? Watch this space for more.





# Introducing Judge Malcolm Simmons

Judge Simmons has been appointed as acting Judge of the Supreme Court of St Helena. The appointment by the Governor, on the recommendation of the Chief Justice Rupert Jones, was made on 20th December and is for 2 years.





## **UK's Chagos deal on hold to allow Trump review**

The UK prime minister's office announced on Wednesday the US president-elect, Donald Trump will now 'consider' the UK – Mauritius deal on the Chagos Islands. President Biden had already given the go-ahead for the deal. However, Trump has turned his inauguration as the 60th president of the United States into a 4-day festival. It starts tomorrow with a firework display at one of the Trump golf courses, followed by receptions, dinners and rallies. The swearing in as president takes place on Monday, 20th January.

A spokesman for Prime Minister Sir Keir Starmer said it was "perfectly reasonable for the US administration to consider the detail" of any agreement. But shadow foreign secretary Priti Patel said the latest development was "complete humiliation" for the prime minister because Labour had been "desperate to sign off the surrender of the Chagos Islands before President Trump returns to office".





It is unclear if Trump's administration would have an objection. The incoming president has not publicly commented on the deal. But the incoming US Secretary of State (Foreign Secretary) has said it poses a "serious threat", arguing it gives the islands to a country aligned with China. Mauritius has a trade agreement with China.

It is said to be unknown how incoming president Trump will act, what advice he might get in office and whether he would have time to consider an issue seen as second-order compared to the wars in Ukraine and the Middle East.

Reports had suggested Mauritian Prime Minister Navin Ramgoolam would sign off an agreement on Wednesday this week as he attended a cabinet meeting, but it was later announced his attorney general was travelling to London to continue talks.

## **How does this affect St Helena?**

For St Helena, this means the opportunity to complete the deal before Trump took office has been missed. The deal we have with the UK government would have finished this month if the UK and Mauritius had finalised their agreement.

Now, there are a range of possibilities for how that agreement develops, or not. For St Helena, the agreement over Chagos migrants runs for a maximum of 18 months or when either the UK or St Helena gives notice of wishing to withdraw from the agreement. It is not expected any change in the UK - St Helena migrant deal will happen before the Trump-led US administration has announced their opinion on the matter.





# CONSTITUTIONAL REVIEW SELF- DETERMINATION

It seems that the articles in this series are now becoming the subject of discussion and debate, in Saint Helena and elsewhere. A letter from Mr Ken Westmoreland is printed in this issue of the Independent. He is clearly supportive of the idea of a changed constitutional relationship between Saint Helena and the United Kingdom, although he differs as to nomenclature and some points of detail.

The description of Saint Helena and the other Overseas Territories as United Kingdom Overseas Territories is the one most commonly used by the United Kingdom Government and its Departments, as in the 2022 paper in the House of Commons Library headed: 'The UK Overseas Territories and their Governors.' I give this simply as one example among many. We will not do ourselves any favours in an approach to the United Kingdom Government concerning constitutional change if we criticise how they choose to describe the Overseas Territories. It is the principle of self-determination that we must concentrate our efforts on.

Self-determination is an internationally recognised human right, enshrined in the United Nations Charter. As the wording of the preamble to Saint Helena's Constitution states: 'all peoples have the right of selfdetermination, by virtue of which they freely determine their political status and freely pursue their economic, social and cultural development.' Which begs the question of what political status the people of Saint Helena aspire to. The present arrangements cause C24, the United Nations Special Committee on Decolonization, to regard Saint Helena as 'non-self-governing' and, therefore, a colony. To be regarded as self-governing, the options are those of independence, a free association with the United Kingdom or full integration into it. As Mr Westmoreland states in his letter, the last of these does bring with it the issue of how Saint Helenians would have the right to vote in United Kingdom Elections in the event of full integration, which would be a requirement of it. There is no obvious practical answer to this, which is why I suggested a seat in the House of Lords, which could be filled by an election here in Saint Helena. As with Bishops sitting in the House of Lords, he or she would vacate the seat when retiring or otherwise ending their time in the role which gives them the seat. Unlike other Members of the House of Lords, Bishops are elected, albeit by a process within the Anglican Church. We do not have enough critical mass to warrant a seat in the House of Commons. Constituencies in the United Kingdom generally have 60/70,000 voters. Being linked with a single constituency or multiple ones in the United Kingdom would not give the island much of a voice, although I appreciate that Mr Westmoreland has suggested how this could be done. It may be that not having representation within the House of Commons would leave us short of full integration, but something close to it could be devised in the form of free association. What we need at the moment is for Saint Helena to develop its own voice in order to put proposals to the United Kingdom for constructive constitutional change. It is the principle that must first be established in order to be able to carry this forward. Saint Helena did not muster much of a voice when it came to the question of introducing Ministerial Government. Only 17% of the electorate took part in the consultative vote and the majority in favour of Ministerial Government was 134, not much of a mandate for constitutional change. It was introduced in 2021 because the United Kingdom Government was in favour of it. Pressing for a closer constitutional relationship with the United Kingdom is not likely to make much progress without a considerable expression of the Island's wish for it.

In theory, at least, the door is open to a new approach. The White Paper, 'BRITAIN AND THE OVERSEAS TERRITORIES – A MODERN PARTNERSHIP', published in 1999, contained the following:

'2.6 Consultation with the territories showed a clear expression of their wish to retain the connection with Britain. We concluded that neither integration into the UK, nor Crown Dependency status, offer more appropriate alternatives to the present arrangements. But these arrangements need to be revisited, reviewed and where necessary revised.'

The italics are mine. Twenty-five years have now passed since that was written and the time has come to revisit, review and revise in order to arrive at a more appropriate alternative to what we have at present.

In April of last year, Synod approved the following resolution unanimously:

'That this Synod passes this resolution to exhort those in positions of leadership to recognise the gradual depopulation and social harm in the present passports-alone circumstance, and to work for a new constitutional arrangement for the Island of Saint Helena.

Saint Helenians need and deserve to find their rights as British citizens on their own Island without being forced to seek them on the mainland. That such a constitutional arrangement is possible is shown in the French model for Saint-Pierre-et-Miquelon. We urge a clear commitment to the long-term future of our Island.'

Saint-Pierre-et-Miquelon is what the French call a collectivité, which translates into English as a community or group of people. In English, the word collective is frequently used, for example, to describe a community or group, such as one of artists, and is a proper rendering in English of collectivité. As explained in my last article, the collectivité of Saint-Pierre-et-Miquelon, a small group of islands situated off the coast of Newfoundland, is regarded for all purposes as part of France.

The more voices in support of the Synod Resolution that those in positions of leadership hear, the more likely it is that some progress will be made. Without urgent attention to this, the day is not far off when the Island will cease to have a viable community left on it.

## Half Tonne of Metal Falls from Space - No-One Killed



Earlier this month a half-tonne metal ring fell from space, landing a safe distance from a village in Kenya. The Kenya Space Authority are analysing the space junk, trying to identify who owned the space vehicle that jettisoned it.

Large objects falling from space is a surprisingly regular occurrence. A small but heavy lump of metal landed on a Florida home in April last year, almost killing one of the family inside. A Japanese satellite company located one of its own bits of space junk which

had been orbiting 370 miles above the earth for 15 years. Weighing 3 tonnes, 36 feet long and 15 wide it is clearly a risk to life should it fall to earth. Astroscale, the Japanese satellite company involved, is developing a business to safely take space junk out of earth orbit.

Most space junk burns up as it descends through earth's atmosphere; however several heavy and high density pieces have survived. The recent Kenya metal ring made a sound like a bomb exploding as it hit earth. People nearby found the ring glowing red hot and could not get near it as it took a long time to cool.

The California sky was lit up at night by the remains of a rocket falling to earth after launching a satellite into space. On another ocassion India owned up to owning a giant metal dome that was washed up on to a beach in Western Australia. There are too many examples of space junk surviving intense temperatures as they fall from space to earth. Astroscale is just one of many techno-companies developing ways to safely pull space junk back to earth. While some say they are on the verge of a breakthrough, a fully functional, proven system cannot come quick enough.

## **Our Ministerial System and the Constitution**

Many Changes Proposed to the Way We Are Governed

### **Assessment Published This Week**

Legislative Council commissioned a review of "the governance structures of St Helena" three years after ministerial government was in place. The review is to assess the effectiveness of constitutional changes introduced in 2021 along with the move to ministerial government. Do the changes deliver efficient, effective, transparent and accountable governance for St Helena?

The Westminster Foundation for Democracy was commissioned for the review. This led to the St Helena Governance Review Team visiting St Helena for the first two weeks of December. Their review is wide ranging and includes extensive consultation with individuals, organisations, elected members and public service officials. The Interim Report was published this week and is intended to be widely available for further feedback. The Review Team pointed out, "This is an interim report, and all findings and recommendations are tentative. We will produce our final report once we have fully engaged with St Helenians and taken on board all their feedback."

Later in the interim report they add. "The Governance Review Team will return to St Helena to follow up on this interim report. We seek your feedback in many ways. When we return to St Helena we will seek feedback through presentations to various groups of stakeholders; in public meetings; via the media; and through one-to-one follow-up interviews. # St Helena Governance Review Interim Report

## The Main Points from the Report

Saints Making Decisions for St Helena

The Interim Report starts by stating "St Helenians are the people best placed to make decisions about what happens on St Helena. This is our view and the view of the clear majority of those to whom we spoke." Shortly after, the report states, "St Helenians making decisions for St Helena is therefore the principle underlying our analysis." There are important considerations to be taken into account in line with this principle. The considerations listed in the report are:-

- The appetite of St Helenians to make decisions.
- The ability, experience, or competence of St Helenians to make decisions.
- The UK's constitutional responsibility for St Helena.
- St Helena's status as a donor-aid-dependent territory combined with the UK's need to ensure that aid money (ultimately coming from UK taxpayers) is properly spent.

The interim report then goes into great detail on the many factors that come into play, in addition to considerations listed. Here, it is only possible to quote the most important or interesting points from it.

Other governance issues connected to Saints making decisions for ourselves includes, "it is unrealistic to expect that St Helena has the personnel to staff all levels of the executive, legislature, judiciary, and public service." And "in a small jurisdiction, conflicts of interest will be inevitable". Another aspect of governance on a small remote island is, "There is not the detachment between decision-maker and citizen that is present in a large jurisdiction. Decision-makers do not have the benefit of anonymity: they will bump into those affected by their decisions every day, and

those affected will know who made the decision affecting them. In some ways this personal relationship provides a level of accountability not seen in larger jurisdictions."

## Speed of implementation of the ministerial system of government

The report states:-

There was widespread agreement that the implementation of the ministerial system in 2021 had been rushed. This meant that:

- Systems were not properly in place in advance of the election.
- Roles and responsibilities were not clear at the outset.
- First years of ministerial government were spent working out roles and responsibilities, developing codes of conduct and so on, reducing the time available for governing.

Having said all this, we are not convinced that delaying implementation to complete these things would have necessarily been the right thing to do. And some matters (such as a Ministerial Code of Conduct) could not have been developed until after the election.

## **Diversity**

The report states:-

Although diversity in government structures was not an explicit part of the terms of reference, the report states it is an important component of good governance. On this issue the report includes, "we were impressed by gender, race, age, and disability diversity within governance structures. In particular two of five Ministers (including the Chief Minister, and Deputy Chief Minister) are female, as is the top public servant, the head of the Governor's office, the Deputy Speaker, and three of seven Councillors." However lack of disabled access to the Council Chamber is seen as an 'urgent issue'. The report comments "This needs fixing right away. If the Speaker believes that this is "a huge problem" then the Speaker should take the lead in dealing with it."

## **Recommendations in the Interim Report**

The number of recommendations runs to 66, however, several recommendations are numbered 2A and 2B or 20A and 20B so the actual total is more than 70. This reflects the depth of detail and extensive scope of the interim report. A considered response to all recommendations, suggestions and views contained in the interim report will certainly require sustained effort.

Here, the Independent highlights some of the first recommendations made. It is not possible to cover all of them at one time. Further information on other recommendations will follow next week.

### **Recommendations**

## **Retain the Ministerial System**

"Government run by Ministers drawn from locally elected politicians is the best way to achieve the goal of St Helenians making decisions for St Helena. Whilst acknowledging that there are many challenges with implementation, we still think it is the most effective form of government for St Helena." The report also observes, "we see no good reason (and no appetite by St Helenians) to return to the committee system."

## Allocation of functions between Governor and ExCo

The report opens this section with, "One of the most basic questions in any state is – "who is in charge?" The answer to this question is not readily apparent from reading the Constitution." The report quotes the constitution "the executive authority of St Helena is vested in Her Majesty" and then comments, "This is a constitutional sleight of hand that is a standard technique of the UK constitution: His Majesty doesn't have any actual power; that power is exercised, in the name of the Crown, by the UK Government. Under s. 34(2), (of the constitution) the executive authority of the Crown is to be exercised, on behalf of the Crown, by the Governor. So, the answer seems quite clear at the outset. The Governor is in charge, because the Governor is the executive authority." Passing on to the constitutional position of Executive Council, the report states, "Even though it has the word "Executive" in the title, there is no statement of its function, nor anything to indicate that it actually has executive functions" and adds, "despite its name, under the strict terms of the Constitution, the Executive Council has no executive functions. All it does is to offer advice to the Governor, who then takes executive action. It would be more accurate to term it an Advisory Council."

Despite the lack of definition in the section of the constitution referred to, the report states reality is different. "In substance though, the position is somewhat different. The obligation of the Governor to "act in accordance with the advice of the Executive Council" is clear from s. 43(1). The power of ExCo to offer binding advice brings them closer to exercising actual executive power".

However, questions remain, "Does the Governor need to be persuaded of something, or just instructed? Ought the Governor to challenge, question or scrutinise advice, or simply meekly accept it? Should the Governor request advice in a series of structured steps to reach a particular conclusion which has been pre-determined by the Governor? Or should the agenda for offering advice be done at the instigation of ExCo itself?"

One comment on this subject states:-

"We cannot reach a definitive finding on the precise power dynamic at play between Governor and ExCo. One perception put to us is that the Governor acts in a colonial manner, informing St Helenians of what needs to be done. Another perception is that the Governor is not an activist, and he does not dictate to ExCo. Some stakeholders thought that the Governor performed a valuable function of acting as a bulwark against bad decision making by ExCo.

We found that the general practice is that, although the Governor may question or probe the advice given by Ministers, he will invariably accept a decision they have made. This a healthy sign of a maturing, and evolving system, and of roles and responsibilities reflecting contemporary approaches."

### **Foot Note**

This description of the Interim Report covers the first 14 pages. The final recommendation, number 66, is on page 60. Beyond that there are 5 annexes. Annex 3 lists the 20 recommendations made by Liam Laurence Smyth, the House of Commons Senior Clerk who visited St Helena in October last year.

Other subjects covered in the interim report, such as the selection of the chief minister, the role of Legco and the legislative programme will be covered next week.



Plaques were presented to all crews as a memento of the 2024 race. Also receiving mementos were the St Helena Yacht Club official timekeeper, the SHYC commodore and the governor.

## Dear Editor,

I would like to thank 'Contributed', whoever he or she may be, for 'Loyal And Unshakeable: How British Is St Helena?' though it is disappointing that the Synod did not submit evidence to either the Public Administration and Constitutional Affairs Committee's inquiry into the Overseas Territories, or the Procedure Committee's one. In any event, both inquiries expired with the

dissolution of the last Parliament before either could publish a report for the Government to respond to.

A couple of small corrections: there are no such things as 'United Kingdom Overseas Territories', only British Overseas Territories, as per the 2002 Act, while St Pierre et Miquelon is an overseas collectivity, not an overseas collective. Using 'UK' as an adjective is an ugly, un-British, pseudo-American internationalism, like 'US' or 'UN', and while the Bishop of St Helena's Citizenship Commission did use the term 'Autonomous United Kingdom Overseas Territory', inspired by the French 'outre-mer' model, it later adopted the less clunky 'British Island', inspired by the Channel Islands and the Isle of Man.

The author writes: 'It is doubtful that Saint Helena could expect, or would even want, representation in the House of Commons', but what evidence is there that this is wanted or unwanted either way? The last time it was considered by councillors was back in 1999, which prompted an aggressive response from the Foreign Office; it sent them an Information Paper telling them that neither integration with the UK nor Crown Dependency status was on offer, the irony being that it had canvassed views on both options from all the Overseas Territories, a bit like vegans asking you if you'd like ham or cheese sandwiches, only for them to attack you for it!

Writing in 2002, Alison Quentin-Baxter, who served as an independent constitutional advisor to the Legislative Council, remarked 'it is not clear what the voters of St Helena would get out of being an insignificant part of a British constituency', but one could say much the same of Gibraltar being combined with the South West England electoral region in the European Parliament before Brexit, even though it had the advantage of being a multi-member constituency.

However, instead of combining St Helena with a single Westminster constituency, each of its 27 enumeration areas could be twinned with one of 27 constituencies, Upper Jamestown with Swindon South, Lower Sandy Bay with Cheltenham, and so on, with each MP becoming a member of a St Helena Joint Standing Committee, along with a selection of peers; the All-Party Parliamentary Group system, a grubby anachronism, would be scrapped.

In addition, if Kelly Yon could speak from those iconic green benches when they hosted the UK Youth Parliament, why shouldn't Julie Thomas be able to do the same were they to host a Joint Parliamentary Assembly, a logical extension of the Joint Ministerial Council? To the best of my knowledge, the Chief Minister has never lived in the UK, so would not even be eligible to vote in its general elections as an overseas elector, unlike her counterpart in Gibraltar, who regained the right to do so despite not having lived in the UK since he was studying at Oxford in the 1990s.

As for the St Helena Government's UK Representative, this should be filled by election, with all holders of St Helenian Status, be they on island or in the diaspora, eligible to vote - in fact, in the nineteenth century, there were suggestions that colonial agents, the equivalent of UK Representatives back then, should have speaking rights in the House of Commons.

If the UK adopted a proportional voting system with multi-member constituencies, as the Liberal Democrats have long advocated, then perhaps St Helena's 2000 plus voters might fit into one, with a choice of MPs from different parties, better than they would into a single member constituency



represented by an MP from a party they didn't like, but I don't see such a system being introduced anytime soon.

And nor do I see the party's more recent proposal, dedicated constituencies for British citizens abroad, being adopted either - hypothetically, St Helena would end up part of a 'Brits in Africa' constituency, with its voters far outnumbered by those in South Africa, though having corresponded with some of their

members of the House of Lords, they seemed snooty even about allowing Saints to vote in that - 'I cannot see a way forward', one told me.

But in fairness to him, if the St Helena Government doesn't express an opinion on the issue either way, how can he be blamed for thinking it doesn't want it?

I have often felt that Napoleon had the last laugh, and that St Helena would have been much better off as the overseas collectivity of Sainte-Hélène, with a deputy in the National Assembly in Paris, and possibly even an outermost region of the EU; indeed, in its report on banking services in the Falklands, the Islands' Chamber of Commerce commented that 'as a rule of thumb the more integrated a territory is to its "metropolis country" the greater breadth and plurality of banking services there is'.

To quote the St Helena Equality and Human Rights Commission: 'If Britain treated its Overseas Territories as British, not foreign, most of the relationship issues would resolve themselves.'



# From the office of the Bishop of St Helena

At the Diocesan Synod held from 5th to 7th of April 2024, Synod passed Mission and Evangelism Resolutions to meet the spiritual needs of God's people in our Diocese. To enable the Diocese to implement these Resolutions, at the request of the Bishop of St Helena, the Diocese of St Helena will have a Growing the Church Mission Team arriving on 14th January 2025. The Mission Team consists of Fr Bruce Wooley (Director of Growing the Church), Dean Buli Wooley and Fr Mark Spyker. The Mission will be launched from 14th January 2025 to 28th January 2025, covering training for clergy, to enable us to have evangelist priests in our parishes, and the laity in all parishes in the following ministries: Making Disciples, Forgiveness, Royal Lessons of Leadership – 70 x 7, Survey of the Bible (Link to Anglicanism), The Work of the Holy Spirit - 70 x 7, Youth & Children's Ministry, The Rewards & Challenges of Ministry, Knowing God's Love, Leading a Small Group, Pastoral Ministry Training and Pastoral Care, Prayer Ministry, Repentance & Renewal, Equipping Leaders – 70x7, Growing the Church Ministry Toolbox and Local Planning.

Fr Bruce Wooley and Dean Buli will leave on the 28th January 2025, after launching the mission and Fr Mark Spyker will continue the mission with Growing the Church Ministry Tool Box Training until 29th March 2025.

It is planned that another Evangelist from Growing the Church will arrive on the 5th April 2025 to 29th June 2025 to continue the Mission and Training.

Venues will be announced and all Parishioners are invited to attend and to hold the Mission in prayer.


These Tamworth pigs seem to be looking over the shoulder of the pig farmer as he watches the Tamworth – Spurs match on his mobile device.



OYSTER The Oyster Rally is right on the heels of the World Arc Rally. This rally is only for yacht owners who have bought an Oyster yacht. Oyster is headquartered at Saxon Wharf,

Southampton. Oyster yacht owners feel they have bought something special for crossing the wide oceans. Oyster yachts are built for comfort as well as cruising.

Like the World Arc Rally, the Oyster Rally started last January in the Caribbean – at Nelson's Dockyard, Antigua on the 14th.



To buy an Oyster 565 you will need to part with around £2 million. For an Oyster 595 you will need to dig a little deeper - with all costs totted up, say goodbye to £2.5 million.



Two Oyster Rally yachts might get here before the leading World Arc Rally yachts. Ahlem, an Oyster 575, is leading the field. The crew have clearly decided to give Walvis Bay a miss and sail straight across the South Atlantic.

We will find out later if the crew are heading straight for Brazil or stopping at St Helena. As with the World Arc crews, most of the yachts are still at Cape Town.

Whatever happens, let's hope the crews that are coming contribute a noticeable amount to the island economy.
